

## How does Galileo calculate PIR values?

Depending on the form type, Galileo automatically transfers the data directly from the input form (in the case of the PIR-AGENCY INFORMATION form) or tallies the number of instances of data items that are influenced by various filters. It is the filters that sometimes make it difficult for users to determine which of their children are not being counted appropriately—they just know their numbers aren't what they expect. What often happens is that the main, numbered item may be correctly checked for the center, class, child, parent, teacher, etc., but other filters may not have data entered, or entered correctly, in which case, the individual will be excluded from a total.

For example, every piece of child data is filtered on item A.12, which asks whether the child is enrolled in Head Start or Early Head Start. This is done so that the total is fed to the correct PIR Output form (we have 2). If a child's primary language is Spanish, and that is selected for the child, but no choice was made for either of the A.12s, then the child will not meet *both* conditions to be included in the total, and will be left out. A situation like this is the cause of 99% of most of the discrepancies users report to ATI.

This document was created to assist in determining the cause of discrepancies by explicitly stating what pieces of data are considered in order for an item to be considered checked off and counted by the Galileo PIR reports. By knowing what filters are applied to items, it is much easier to know where to look for missing or incorrect data when totals on the PIR do not display the totals users expect. This document is organized identically to the PIR Output Report. On the left, you will find the items as they display on the PIR Output Report; on the right, you will find an explanation of the formula for each item, and in some cases, images depicting the item to help you find it on the 7 input forms.

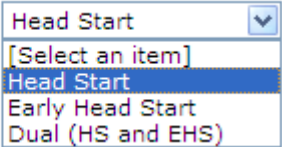
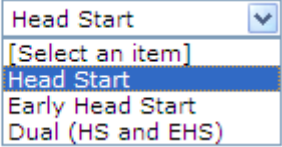
